WHAT DOES THE FUND INVEST IN?

The fund invests primarily in real estate investment trusts ("**REITs**"), equity securities of corporations carrying on business in the real estate sector and debt or convertible debt issued by REITs and real estate corporations. The fund may invest up to 30% of the net asset value in equity securities and convertible debentures of non-Canadian REITs and corporations carrying on business in the real estate sector, so long as such securities are listed or quoted on a major North American exchange. At the Fund Manager's discretion, the fund may be invested entirely in cash or cash equivalents.

HOW RISKY IS IT?

The value of the fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

RISK RATING

The Fund Manager has rated the volatility of this fund as **Medium.**

This rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.



HOW HAS THE FUND PERFORMED?

This section tells you how Series A securities of the fund have performed over the past 10 calendar years. Returns are after expenses have been deducted. These expenses reduce the fund's returns.

Year-by-Year Returns

This chart shows how Series A securities of the fund performed in each of the past 10 calendar years. This fund series dropped in value in 2 of the last 10 calendar years. The range of returns and change from year to year can help you assess how risky the fund has been in the past. It does not tell you how the fund will perform in the future.

Average Return

As at March 31, 2023, a person who invested \$1,000 in Series A securities of the fund 10 years ago has \$1,928. This works out to an annual compound rate of return of 6.79%.

WHO IS THIS FUND FOR?

The fund is suitable for investors who:

- Are seeking a growth fund investing in the real estate sector;
- Have a long-term investment horizon; and
- Are prepared for a medium level of risk.

A WORD ABOUT TAX

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan such as a Registered Retirement Savings Plan, or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions (including taxable capital gains) are included in your taxable income, whether you get them in cash or have them reinvested.

HOW MUCH DOES IT COST?

The following tables show the fees and expenses you could pay to buy, own and sell Series A securities of the fund. The fees and expenses – including any commissions – can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

1. Sales Charges – You have to choose a sales charge option when you buy Series A securities of the fund. Ask about the pros and cons of each option.

2. **Fund Expenses** – You don't pay these expenses directly. They affect you because they reduce the fund series' returns. As at December 31, 2022, the total fund series' expenses were 2.43%. This equals \$24.30 for every \$1,000 invested.

Effective April 16, 2021, the fund pays a fixed rate administration fee of 0.13% and Certain Fund Costs, in lieu of operating expenses, as set out in the fund's simplified prospectus.

More about the trailing commission – The trailing commission is an ongoing commission. It is paid for as long as you own the fund. It is for the services and advice that your representative and dealer provide to you.

The Fund Manager pays the trailing commission to your dealer. It is paid from the fund's management fee and is based on the value of your investment. The rate depends on the sales charge option you choose. The trailing commission paid to a representative, as an annual percentage of the net asset value of the Series A securities owned, is as follows:

3. Other Fees - You may have to pay other fees when you buy, hold, sell or switch Series A securities of the fund.

WHAT IF I CHANGE MY MIND?

Under securities law in some provinces and territories, you have the right to:

- (i) withdraw from an agreement to buy mutual funds within two business days after you receive a simplified prospectus or Fund Facts document, or
- (ii) cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
